TERMS OF USE

In case you take legal action, you are informed that our content is valued at

25.55 Mexican Pesos, this per download, to which you must pay compensation for

damages caused. This price will be **\$25.55 MX** (Value of content per download) for the number of

downloads and/or valued content. (Value of content * Quantity of content * Downloads).

To reach an agreement you must first fill out this form, to obtain important

information about yourself (Commercial agreement form Spanish English). If we detect anything unusual,

we reserve the right to contact you to confirm the agreement.

Proper Use
